OLD BUSINESS: There was no old business.

A motion to approve the minutes of the March 2, 2026, meeting was made by Councilor FitzGibbons and seconded by Councilor Lautensack. Minutes were approved by a vote 2-0-1.

NEW BUSINESS:

- 1. The Zoning and Planning Office requests authorization for the Common Council to approve the Verizon Wireless Telecommunications Facility Modification application for the co-location of antennas at 300 East Albany Street.**

Zoning and Planning Administrator, Jeff McGann, explained that the proposal for 300 East Albany Street involves adding another carrier to an existing cell tower, noting it had already gone through the planning board and returned for a final council decision with no physical changes to the structure. Councilor FitzGibbons commented that the project is straightforward, as it uses the same equipment and does not alter the tower's overall nature.

COMMITTEE DECISION: Councilor FitzGibbons made a motion to forward a favorable recommendation to the Full Council the request from the Zoning and Planning Office. Councilor Lautensack seconded the motion, it was approved 2-0-1.
